## 2021-22 SEASON-Regulation Bulletin No. 3 – May 11, 2022

Beginning **June 15, 2022** through August 31, 2022 the minimum interstate grade for Valencia & Late Type Oranges is U S # 2 with an internal grade of U.S. #1

- Ambersweet orange maturity standards are in Department of Citrus Rule Chapter 20.13
- Fresh grapefruit maturity standards are outlined in the Packing House Maturity Chart

The grade and size regulations shown below are separated into Interstate and Export. Interstate shipments include the continental United States (except Florida East and South of the Suwannee River). Puerto Rico, Canada and Mexico are export markets.

Notes: U.S. Grade Standards for Florida Citrus apply to all grades, except for the grapefruit minimum maturity, which is defined in Marketing Order 905, and except for Florida Grade Standards for Honey tangerines as defined in Florida Citrus Commission Rule No. 20-35.003. All sizes are stated in terms of 4/5-bushel containers.
